1.1 GENERAL

1.1.1 Noida Metro Rail Corporation Ltd. invites open e-tender through e-tendering system (i.e. Technical and Financial bid) from eligible applicants who fulfill qualification criteria as stipulated in NIT/RFP for “**Supply of CMV Spare Parts for Traction Department**”.

Note: (i)) Tender Cost and Tender Security is exempted for Micro & Small Enterprises (MSEs) registered with District Industries Centre or Khadi & Village Industries Commission or Khadi & Village Industries Board or Coir Board or National Small Industries Corporation or Dte. Of Handicraft & Handloom or any other bodies specified by Ministry of Micro, Small & Medium Enterprises for appropriate category and have valid registration certificate as on date of tender submission.

The MSEs would not be eligible for exemption of tender security if:

- a. Either they are not registered for appropriate category.
- b. Or they do not have valid registration as on the date of tender submission.

The bidders seeking exemption from 'tender security', being MSEs, shall ensure their eligibility w.r.t above and submit registration certificate issued by the body under which they are registered which clearly mentions category of registration i.e. **“Manufacture of specialized parts of railway or locomotives or of rolling stock” and Terminal Validity of registration.**

In absence of any of the above requirements no exemption for 'tender security' will be allowed and bidder's eligibility shall be dealt as if they are not registered with MSMEs.

No further clarification shall be sought on the above.

1. In case the bidder who has been exempted Tender Cost/Tender Security being Micro & Small Enterprise, and;

- (i) withdraws his Tender during the period of Tender validity; or
- (ii) becomes the successful bidder, but fails to commence the work (for whatsoever reasons) as per terms & conditions of Tender; or
- (iii) refuses or neglects to execute the contract; or
- (iv) fails to furnish the required Performance Security within the specified time,

The bidder shall be debarred from participating in future tenders for a period of 1 year from the date of discharge of tender/date of cancellation of NOA/annulment of award of contract as the case may be. Thereafter, on expiry of period of debarment, the bidder may be permitted to participate in the procurement process only on submission of required Tender Cost/ Tender Security.

Further the Employer may advise the authority responsible for issuing the exemption certificate to take suitable actions against the bidder such as cancellation of enlistment certificate etc.

1.2 Minimum Eligibility Criteria:

The Bidder's competence and capability is proposed to be established by the following parameters. The Bidder should meet all the criteria given in this section:

- a) Sole proprietorship, registered partnership firm (including LLP), public limited company, private limited company can submit the Bid. The firms and the companies should be registered in India.
- b) The Bidder should have completed in India during last 7 (Seven) years period ending last day of month previous to the one in which the bids are invited should be either of the following:
 - i. One order of similar nature of value not less than Rs. 21.28 lakh (Rupees Twenty One Lakh Twenty Eight Thousand only) or
 - ii. Two orders of similar nature of value not less than Rs 13.30 lakh (Rupees Thirteen Lakh Thirty Thousand Only) each or
 - iii. Three orders of similar nature of value not less than Rs 10.64 lakh (Rupees Ten Lakh Sixty Four Thousand Only) each.

Definition of Similar Work: Works involving supply/manufacturing of spare parts for Rolling Stock in Railways or Metro Rail Projects.

- c) Bidders are required to enclose copies of the work orders and work completion certificate and performance certificate from any Metro/Railway organization with the Technical-Bid. Work completion certificate clearly indicating the nature/scope of work, actual completion cost and actual date of completion for such work, without proper and valid certificates from the Employers, bid will be rejected.
- d) The Bidder should have minimum average annual turnover of Rs. 26.60 Lakh (Rupees Twenty Six Lakh Sixty Thousand only) in the last 3 (three) Financial Years (2021-22, 2022-23, 2023-24) preceding the Bid Due Date..
- e) Profit before tax should be positive in atleast 1 (one) year; out of the last 3 (three) audited financial years.
- f) The Bidder or its owners/partners have not been blacklisted/ banned/ declared ineligible for corrupt and fraudulent practices by the Government of India/ any State Government/ Government Agency and any court of law and contracts have been terminated/ foreclosed by any company/department due to non-fulfillment of Contractual obligation in last 5 (five) financial years.
- g) The Bidder should be registered with the Goods and Services Tax Authority.
